PPI came out on Thursday the 26th of March and some notable differences were witnessed in indices closely monitored by the construction and civil engineering industry. This Week at SAFCEC

This week was training and education focussed.

We explained all the processes around the **CETA** and our efforts to rectify the situation from the employers' side;

- We wrote to the Minister of Labour asking for an audience and requested that CETA be put under administration.
- The employer bodies suspend their activities/participation in the CETA structures at all levels, although it was specifically said that individual companies must carry on with their links with it.
- The Minister then suggested meetings between the parties to try and solve the impasse.
- This culminated in three mediation meetings where problems were identified and actions defined to address them.
- A CETA Council meeting took place yesterday where the new Council was elected, as well as a new Exco with Gavin Strydom of the MBSA as new chairman.
- A new Constitution was also approved barring one or two outstanding issues.

All of these are important building blocks towards a better functioning CETA and we hope we can achieve this.

Elardus Rademeyer and Ernest de Jager have been going around the country talking to regions about the mandate for the upcoming **wage negotiations**. We thank members for their participation and will rely on you heavily to have a positive outcome for this process.

CU has been very busy helping **SANRAL** to build the **enterprise development** and training and education into their future contract documents. She has been supported by members of the training committee.

The **Transformation Charter** process moved one step closer to a Sector 9 Code with the documents (mandated compromise position) submitted to the Department of Trade and Industries. We hold thumbs that this will be signed before the elections.
